MINUTES OF THE HEARING BEFORE THE NEVADA STATE CONTRACTORS BOARD JANUARY 13, 2022

CALL TO ORDER:

The hearing for LCB File No. R021-21 was called to order at 8:30 a.m. on Thursday, January 13, 2022 at a tele-meeting via Zoom. Exhibit 1 is the Notice of Intent to Act Upon a Regulation and a copy of the proposed regulation.

Ms. Grein stated the notice of the hearing was posted in compliance with the open meeting law on the Board's Website, the Nevada Public Notice Website, State Library and Archives, the Nevada Register, both offices of the Nevada State Contractors Board, and e-mailed electronically to persons who have expressed interest in being kept informed of the Board's meetings.

Mr. Grein explained the purpose of the hearing is to receive comments from interested parties concerning the proposed regulation identified as LCB File R021-21. The proposed regulation would amend NAC 624.590 to grant credit towards the satisfaction of a portion of the experience requirement for licensure to applicants who have completed certain occupational and vocational training programs as provided for in AB 330 passed during the 2021 legislative session. This regulation also makes minor changes to NAC 624.640 related to the display of license certificates and repeals NAC 624.678 in regards to duplicate licenses.

A workshop was held on this matter on January 6, 2022. No public comment was received during the workshop and to date, no written comments have been received.

PUBLIC COMMENT:

There were no online public participants to offer public comment and no written public comment was received.

Mr. Grein stated this matter will be considered for adoption by the Board on January 20, 2022. The workshop was adjourned at 8:32 a.m.
